Singapore Visa Description A Singapore Visa is an official travel authorization that permits eligible foreign nationals to enter Singapore for purposes such as tourism, business, social visits, medical treatment, or transit. The visa is generally issued as an electronic visa (e-Visa) and is subject to the approval of the Immigration & Checkpoints Authority (ICA) of Singapore. Applicants may be required to submit a valid passport, recent photograph, completed visa application form, proof of travel arrangements, accommodation details, and other supporting documents depending on the purpose of the visit. Having a valid visa does not guarantee entry, as admission is determined by immigration authorities upon arrival. Visa validity, entry type (single or multiple entry), and permitted stay duration vary based on the applicant's nationality and the visa issued. - Land arrangement details from a Singapore tour operator with a scanned copy of the itinerary.
- Covering Letter addressed to "The Visa Officer, Singapore High Commission," mentioning the duration, purpose of visit, and expenses clause.
- Flight & Hotel Confirmation
- Mobile number and email ID of the applicant.
- Original Company NOC with stamp and signature.
- Payslips of the last 3 months.
- Cover letter on company letterhead with stamp and signature.
- Supporting documents like company memo, partnership deed, establishment license, etc.
- Leave letter/report card issued by the school. (For Students)
- School ID. (For Students)
